

Mi Via participants or employers of record (EORs) are required to determine the rate for their employees/services within the range of rates listed in this document and indicate the rate of pay in the budget request and the *Employee Agreement and/or Vendor Agreement*. Justification for paying more than these rates must be submitted for consideration and approval to the Third Party Assessor (TPA) along with the budget. All codes in the T1999 category (related goods) are paid at the amount approved by the TPA. Approval by the TPA is subject to the Mi Via regulations 8.314.6 NMAC.

For services listed that have no minimum rate, the EOR may negotiate a lower rate, but is responsible for researching and ensuring payment of at least the minimum wage (to employees) which includes state, federal, and in some instances, “living wage.” Please refer to the state website for further information: [www.jobs.state.nm.us](http://www.jobs.state.nm.us).

These rates do not include taxes. Consultants are required to use the calculator tool provided in GCES to determine correct amounts (rate of pay or cost of goods) before submitting the annual budget or revision to the TPA for approval.
