NEW MEXICO INFLUENZA SURVEILLANCE UPDATE from the Epidemiology and Response Division of the New Mexico Department of Health (NMDOH) Weekly Report ending March 5, 2005

Summary of Influenza Activity in New Mexico for Week Ending February 26, 2005:

- Eighteen of the 18 sentinel sites reported a total of 4819 patient visits, of which 75(1.56%) were for an influenza-like illness¹. The previous week ending February 26 reported 1.43 % influenza-like illness.
- NMDOH received reports of 57 patients with positive influenza (32 influenza A, 17 influenza B, 8 indistinguishable²) tests using rapid testing. There was one report of positive influenza A culture, and one report of positive influenza B culture.
- NMDOH reported the state influenza activity as “LOCAL” to the Centers for Disease Control and Prevention (CDC) (see table below for definitions). Region IA (Bernalillo County) reported ILI of greater than 2.5.

Laboratory Activity in NM:

- To date this season, there has been 28 influenza A virus isolates (21 subtyped as H3)* and 32 influenza B isolates (30 subtyped as Shanghai-like)* identified by culture at NMDOH Scientific Laboratory Division (SLD). After the first report of culture-confirmed influenza for the season, influenza activity reported to the CDC includes results from influenza rapid testing, fluorescent antibody (DFA) methods, or cultures.
- For the week ending March 5, 2005, 13 clinical laboratories reported performing 508 rapid or DFA tests, of which 32(6.30%) were positive for influenza A, 17(3.35%) were positive for influenza B and 8(1.57%) were indistinguishable².
- Since October 24, 2004, NMDOH has received reports of 275(5.96%) positive influenza A tests, 211(4.57%) positive influenza B tests and 48(1.04%) indistinguishable² positive influenza out of 4616 rapid tests performed at 16 clinical laboratories.

*These cases may also be counted among the rapid test positive results.

Influenza-related Pediatric Mortality

During the week ending February 26, there were four influenza-related pediatric deaths reported to CDC. A total of thirteen cases of influenza-associated pediatric deaths have been reported nationally to CDC from ten states this season (California, Georgia, Maine, Massachusetts, Mississippi, New Jersey, New York Ohio, Pennsylvania and Vermont). No cases have been reported to the NMDOH.

¹ Influenza-like Activity (ILI) is defined as Fever ($\geq 100^{\circ}\text{F}$ [37.8°C], oral or equivalent) AND cough and/or sore throat in absence of a KNOWN cause other than influenza.

² Some rapid influenza tests cannot differentiate between types A and B.

Flu Activity in the Region

For the week ending February 26 (the most recent data available), influenza activity was reported as “widespread” by Colorado, Idaho, Montana, Nevada, Texas and Utah and “regional” by Arizona and Wyoming and “local” by New Mexico. There were 32 reports of influenza A (H3N2) virus, 41 influenza A that were not subtyped and 46 influenza B viruses in the Mountain region (Arizona, Colorado, Idaho, Montana, Nevada, New Mexico, Utah and Wyoming).⁴

National Flu Surveillance and Laboratory Activity

For the week ending February 26, 2005, 1,025 (21.0 %) of 4,875 specimens tested for influenza viruses were positive. Of these, 142 were influenza A (H3N2) virus, 631 were influenza A that were not subtyped, and 252 were influenza B viruses. Nationwide 4.6% of patient visits to U.S. sentinel providers were due to influenza-like-illness. Thirty states reported widespread activity, 16 states reported regional activity and 3 states reported local activity nationally. 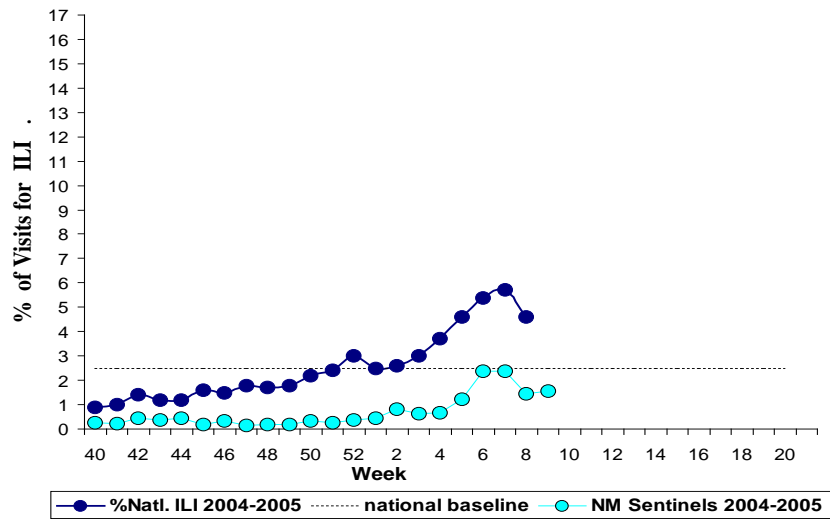
* ILI activity can be assessed using a variety of data sources including sentinel providers, school/workplace absenteeism, and other syndromic surveillance systems that monitor influenza-like illness.

[†] Lab confirmed case = case confirmed by rapid diagnostic test, antigen detection, culture, or PCR. Care should be given when relying on results of point of care rapid diagnostic test kits during times when influenza is not circulating widely. The sensitivity and specificity of these tests vary and the predictive value positive may be low outside the time of peak influenza activity. Therefore, a state may wish to obtain laboratory confirmation of influenza by testing methods other than point of care rapid tests for reporting the first laboratory confirmed case of influenza of the season.

[‡] Institution includes nursing home, hospital, prison, school, etc.

^{**}Region: population under surveillance in a defined geographical subdivision of a state. A region could be comprised of 1 or more counties and would be based on each state's specific circumstances. Depending on the size of the state, the number of regions could range from 2 to approximately 12. The definition of regions would be left to the state but existing state health districts could be used in many states. Allowing states to define regions would avoid somewhat arbitrary county lines and allow states to make divisions that make sense based on geographic population clusters. Focusing on regions larger than counties would also improve the likelihood that data needed for estimating activity would be available.
