NEW MEXICO INFLUENZA SURVEILLANCE UPDATE Summer 2009

Week Ending	Activity Level
8/22/09 (MMWR Week 33)	Local

“Local” activity is defined by the Centers for Disease Control and Prevention as increased influenza-like illness (ILI) activity in one region AND recent (within the past 3 weeks) lab-confirmed influenza in the region with increased ILI.

Monthly Summary of State-wide viral test samples (PCR and cultures) submitted to the Scientific Lab Division (SLD) from late April – late July, 2009 (Current period of influenza surveillance activity)¹:

Summary of Influenza Outpatient Surveillance in NM for Week Ending 8/22/09¹:

Twenty-two of the 22 sites reporting:

- total of 6,936 patient visits seen for any reason,
- 59 (0.9%) were positive for influenza-like illness (ILI)², and
- previous week (ending August 15th) reported 0.9% influenza-like illness.

**Includes rapid antigen and immunofluorescence testing (i.e., direct fluorescent antibody staining)

Note: The sensitivity and specificity of point of care rapid diagnostic tests vary during times when influenza is not circulating widely. The NM Influenza Surveillance Program expects some false positive rapid diagnostic results outside the time of peak influenza activity (i.e., beginning and end of season). The first NM laboratory confirmed case of the influenza season is based on a positive **viral culture** result.

¹ Weekly ILI and lab data may change as additional reports are compiled.

² Influenza-like Activity (ILI) is defined as Fever ($\geq 100^{\circ}\text{F}$ [37.8°C], oral or equivalent) AND cough and/or sore throat in absence of a KNOWN cause other than influenza.

³ Some rapid influenza tests cannot differentiate between types A and B.

Pediatric Influenza-Related Mortality:

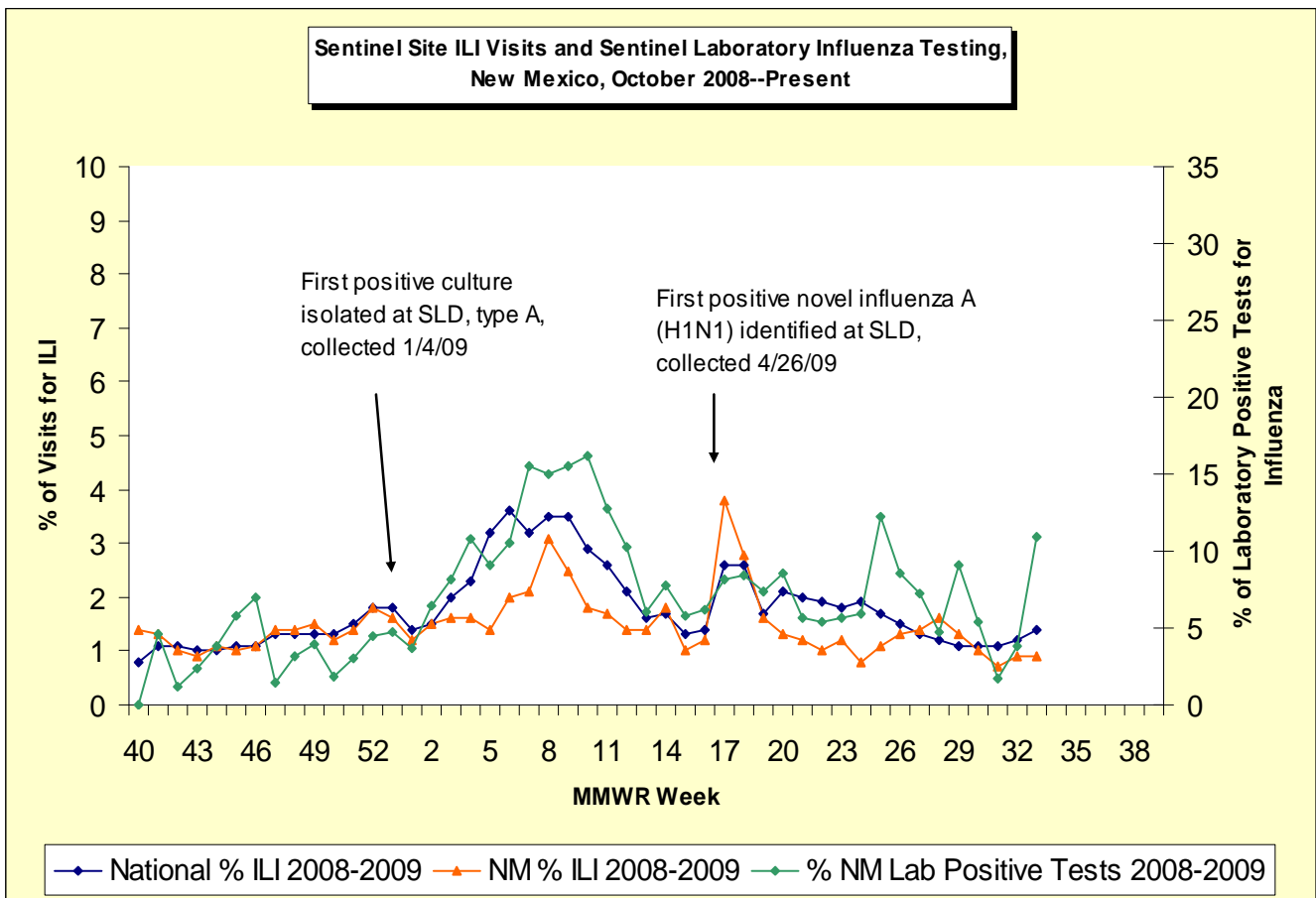
Since October 2008 to present, a total of 110 pediatric deaths have been reported to CDC in this season, 42 of which were due to novel influenza A (H1N1) virus infections. There have been no influenza-related pediatric deaths reported in New Mexico during that time period.
