

### New Mexico Department of Health 2015 Weekly Infectious Disease Report Week 44 November 1, 2015 - November 7, 2015

This report is prepared by the Infectious Disease Epidemiology Bureau (IDEB) for notifiable infectious diseases reported through the New Mexico Electronic Disease Surveillance Systems (NM-EDSS). NM-EDSS is a web-based system used by public health staff throughout the state to track investigations of suspected, probable and confirmed cases of notifiable infectious diseases. 
### Monthly Trends for Selected Notifiable Infectious Diseases As of November 7, 2015




#### Number of Reported Cases of Campylobacteriosis by Month




#### Number of Reported Cases of Giardiasis by Month




#### Number of Reported Cases of Pertussis by Month




#### Number of Reported Cases of Salmonellosis by Month
