

### New Mexico Department of Health 2016 Weekly Infectious Disease Report Week 36 September 5, 2016 - September 10, 2016

This report is prepared by the Infectious Disease Epidemiology Bureau (IDEB) for notifiable infectious diseases reported through the New Mexico Electronic Disease Surveillance Systems (NM-EDSS). NM-EDSS is a web-based system used by public health staff throughout the state to track investigations of suspected, probable and confirmed cases of notifiable infectious diseases. 
### Monthly Trends for Selected Notifiable Infectious Diseases As of September 10, 2016




#### Number of Reported Cases of Campylobacteriosis by Month




#### Number of Reported Cases of Giardiasis by Month




#### Number of Reported Cases of Pertussis by Month




#### Number of Reported Cases of Salmonellosis by Month
