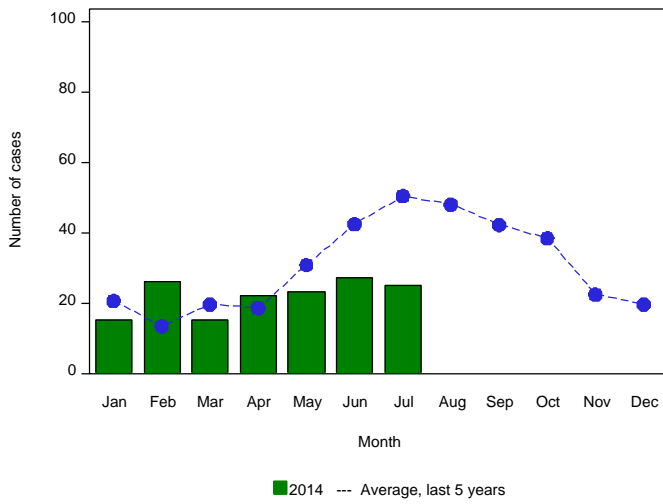

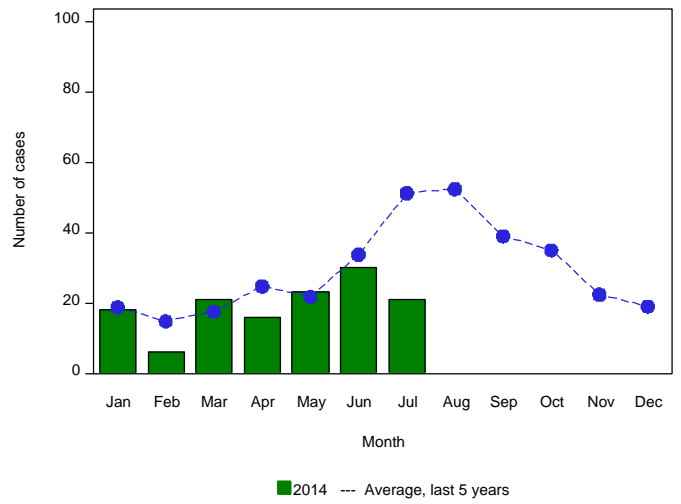
Monthly Trends for Selected Notifiable Infectious Diseases As of July 26, 2014

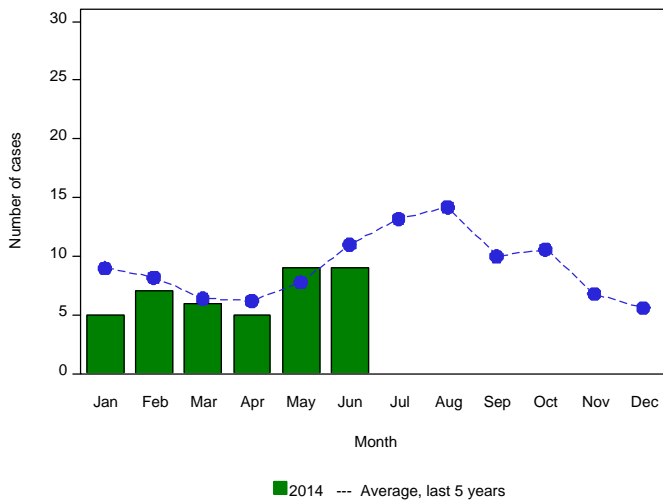
Incidence of Campylobacteriosis by Month



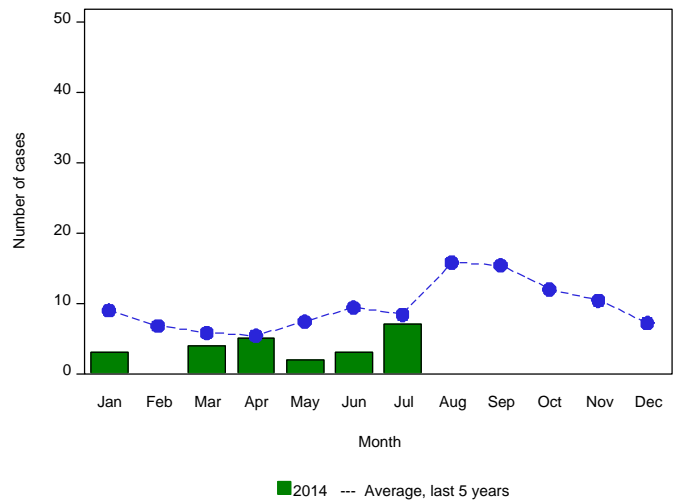
Incidence of Salmonellosis by Month



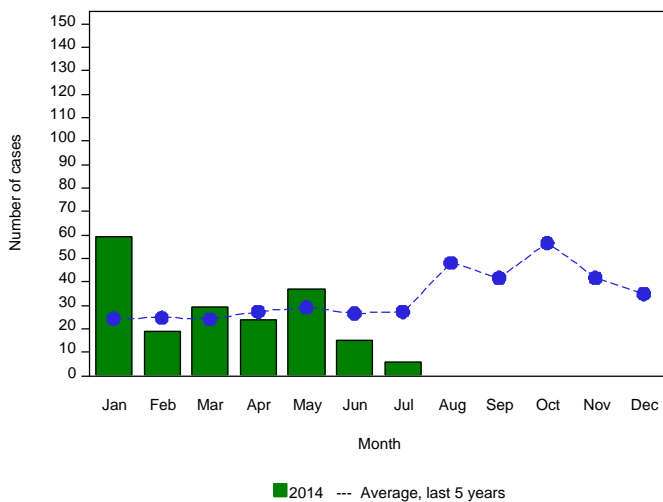
Incidence of Giardiasis by Month



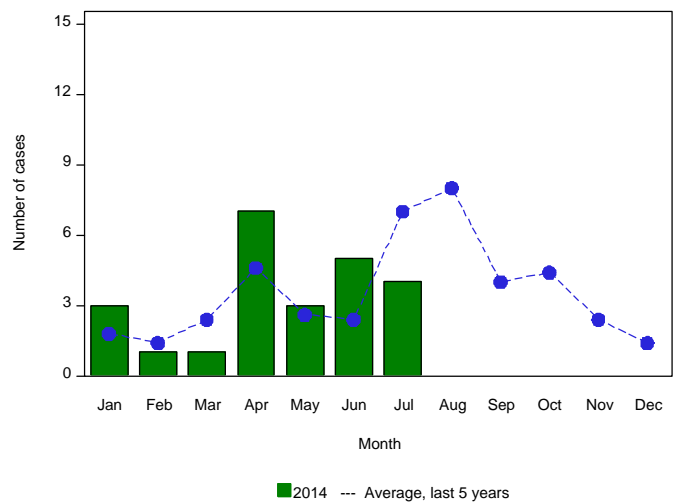
Incidence of Shigellosis by Month
