
## Monthly Trends for Selected Notifiable Infectious Diseases As of August 2, 2014



#### Incidence of Campylobacteriosis by Month




### Incidence of Salmonellosis by Month




#### Incidence of Giardiasis by Month




#### Incidence of Shigellosis by Month
