



Request to Change Gender Designation on a Birth Certificate -Parent/Legal Guardian

Who may request a change?

An individual who was born in New Mexico and wants to change their gender designation on their birth certificate may request the change using this form.

What is required under NMSA 24-14-25?

- The request form must be completed and signed by a parent or legal guardian on behalf of the individual wanting to change the gender designation on their birth certificate. Legal guardians acting on behalf of the minor must include proof of legal guardianship (i.e. certified court order).
- The request form must be signed in the presence of a Notary Public.

Applicable Fees

There is a \$20 fee to amend the record and to change the name, if applicable, this fee includes one certified copy of the new birth certificate. If you want additional certified copies of the new birth certificate, complete a [Certificate Order Form](#) and include an additional \$10 for each certified copy requested. Make check or money order payable to New Mexico Vital Records.

Additional Information

If your child is under 18 years old and you have not legally changed their given first and middle names, you must provide a certified legal name change court order with this request form. If you want their full current legal name amended on their birth certificate, indicate by checking the appropriate box. Additional proof documentation might be requested. Use by government agencies

At this time we are unsure if other agencies, such as Passport, will accept these amended certificates. For those that include change of gender, nothing on the record will indicate a change was made. This will make it difficult to connect the current record with the previous name on other documentation. In some cases, a court order might be needed for full use of the new name and gender designation.
