DISCIPLINARY ACTIONS AS OF 09/12/2019

Final enforcement actions shall be posted for a minimum of 4 years or until the end of any probationary term or period of deferment, whichever is longer.

The information in this section is intended to provide public notice of disciplinary actions taken by the New Mexico Department of Health and the Emergency Medical Systems Bureau. Note that there may be various actions that are still in process, but have not yet been completed due to the administrative process. Approximately 8000 EMT's and EMD's are licensed in New Mexico.
