

# QUICK REFERENCE GUIDE:

## Medical Cannabis Program and Adult Use Cannabis

	MEDICAL PROGRAM	ADULT USE (Recreational/Commercial)
<b>Application Required</b>	<b>Yes</b>	<b>No</b> – Anybody 21 or older
<b>Age Limit</b>	<b>No</b> – however, anyone under 18 requires a parent or guardian to be their caregiver.	Must be over 21
<b>Possession Amount</b>	Up to 425 units (approximately 15 ounces dried flower/bud) of cannabis. Unlimited at home.	Up to 2 ounces of cannabis, 16 grams of extract, or 800 milligrams of edible cannabis. Unlimited at home.
<b>Use in Public</b>	<b>No</b>	<b>No</b>
<b>Purchase Limit</b>	May purchase up to 15 ounces (425 units) of cannabis in any 90-day period with no tax. Once 15 ounces in 90 days is reached additional purchases can be made through Adult Use.	May purchase up to 2 ounces of cannabis, 16 grams of extract, or 800 milligrams of edible cannabis at one time.
<b>Personal Sales</b>	<b>No</b>	<b>No</b>
<b>Gifts – Must Be Provided Without Financial Consideration</b>	<b>Yes – to those over 18 who are enrolled in the Medical Cannabis Program.</b> Cannabis may not be exchanged for money, goods, or services.	<b>Yes – to those over 21,</b> must follow possession limit, Cannabis may not be exchanged for money, goods, or services.
<b>Personal Production</b>	Anyone 21 or older may grow up to six mature plants and six seedlings. Max of 12 mature per household. <b>No special license required.</b>	Anyone 21 or older may grow up to six mature plants and six seedlings. Max of 12 mature per household. <b>No special license required.</b>
<b>Use in Vehicles</b>	<b>No</b> - highways and streets are considered public place and it is illegal to operate vehicles while under the influence.	<b>No</b> - highways and streets are considered public place and it is illegal to operate vehicles while under the influence.
<b>Out of State Product</b>	<b>No</b> – must be an intrastate (in-state) purchase	<b>No</b> – must be an intrastate (in-state) purchase

<b>Use Around Children</b>	Use around children is not recommended and adults must ensure their use does not put the child (or children) at risk.	Use around children is not recommended and adults must ensure their use does not put the child (or children) at risk.
<b>Transporting Product/possession Limit Outside of Home</b>	Patients may transport up to 15 ounces (425 units) at any one time. May also transport plants when moving from one location to another. Refer to <i>Adult Use</i> for additional information.	Adults over 21 may transport up to 2 ounces of Cannabis, 16 grams of extract, or 800 milligrams of edible cannabis. Unlimited at home. May also transport plants when moving from one location to another.
<b>Product in Original Packaging</b>	Should keep in original packaging. If original packaging is damaged, should still retain label.	Should keep in original packaging. If original packaging is damaged, should still retain label.
<b>Probation/Parole Protection</b>	<b>Yes</b> – may use for medicinal purposes based on orders from the court.	<b>Depends</b> - Based on orders from the court (or probation or parole requirements).
<b>Reciprocal (Out of State) Cards</b>	<b>Yes</b> – The reciprocal participant must register at a dispensary. Products must be from an intrastate (in-state) source. <b>Please note: There is no reciprocal use of product from another State.</b>	Any individual over the age of 21 may purchase from a legal dispensary. Products must be from an intrastate (in-state) source. <b>Please note: There is no reciprocal use of product from another State.</b>
<b>18-20 Year Old Individuals</b>	<b>Yes</b> - Individuals between the ages of 18-20 may enroll and purchase as part of the medical cannabis program.	<b>No</b> – An individual must be 21 or older to purchase and be in possession.
<b>Minors (under 18 years old)</b>	<b>Yes</b> - Individuals under the age of 18 may enroll with a registered adult Caregiver (who is over 18) in the Medical Cannabis Program. A <b>minor patient may not purchase</b> medical cannabis. The Registered <b>Caregiver must purchase</b> the medical cannabis for the minor.	<b>No</b> – An individual must be 21 or older to purchase and be in possession.
