I get a lot of questions asking the difference between the DD Waiver and Mi Via. Can you please elaborate a little? Thank you.	Once an individual receives an allocation to the DD Wavier the individual will be provided a choice between the Mi Via waiver or the traditional DD Waiver. Mi Via is a self-directed waiver and DD Waiver is known as the traditional waiver. One of the key differences between self-direction and traditional DD Waiver is the model of service delivery. Under traditional DD Waiver service, delivery is provided through agency providers that have been approved by Department of Health (DOH) and have a Medicaid agreement with them. Under Mi Via or self-direction, the individual has what DDSD calls employer authority and can hire employees directly and this may include someone that lives in their community. There are a system of supports in place to help with payment and cutting checks to the employees and some training and supports about managing time sheets and hiring and selecting employee.

On October 1, 2020 rate increases for a number of DD Waiver services were approved by CMS based on 2019 Rate study conducted by Public Consulting Group and based on legislative appropriation. An additional targeted rate study was conducted by PCG over the last six months which resulted in recommendations for therapies and BSC Without further legislative appropriation, rate increases cannot be implemented. Budget planning occurs in advance so, the state may look at FY 23 budget request.
