MEETING MINUTES

- I. Introductions:
 - a. There was a quorum of Council Members.
 - b. Council Members introduced themselves and guests were welcomed.
- II. Review of the Agenda:
 - a. The Agenda was reviewed and accepted.
- III. The minutes were reviewed and approved unanimously. As a reminder, minutes for previous meetings will be posted to the Council Website for review.
- IV. Council Membership:
 - a. There are no additional changes in the membership.
- V. Legislative Session Results:
 - a. A discussion regarding how the legislative was regarding issues related to the recommendations from 2022 and other related items during the 2023 Legislative session. There was activity around every one of the recommendations, overall successful. Phil F. mentioned the discussions about the Overdose Prevention Facilities and how it did not reach a floor vote, but engendered discussion and questions during the committee hearings.
 - b. Michael P. mentioned the co-pay bill passed for lower copays in chiropractic practice and the Medicaid project is moving forward.

 - d. Increased funding toward overdose prevention and opioid settlement funds (both DOH and HSD).

- VII. Subcommittee Updates and Recommendations
 - a. Emerging Trends Phil Fiuty
 - i. Bill about overdose prevention centers did not pass but had some discussion and anticipates it will be presented (or another form of it) in the future.
 - ii. The MOUD in corrections bill did pass with full implementation by 2026. Had a lot of discussion and gathered a lot of support.
 - iii. Advanced drug checking services also is a project currently moving forward, including hiring of personnel.
 - iv. Discussion about what types of substances being used (xylazine, ketamine, benzos, etc....) and some complications (odd wounds, for example). Some samples of substances have been gathered and sent for testing, and some questions about how testing is occurring (strips, etc....). Steve J. brought up issues with internet prescribing (Ketamine, Adderall) and to please forward that information to him as it is something they are interested in following.
 - b. Methamphetamine Subcommittee The subcommittee has not had the chance to meet due to some continuing changes of the committee members statuses.
 - c. Integrative Medicine Subcommittee Michael Pridham further action steps to further integrative treatment options, increase information on options for integrative treatment options with Turquoise Care and with UNM and access issues. Continue to work on interim hearings with regard to the legislature.
- VIII. Other Business:
 - a. Joanna K. raised question about possible availability of OTC naloxone in the next year. Phil was able to bring up some other groups which are making recommendations for pharmacists and educational materials. Joanna raised concerns about stigma when patients approach pharmacy counters. Other discussions about OTC and possible concerns about pricing. It would have minor impact on the overall state distribution of naloxone through DOH and HSD.
