## **REVIEW OF MINUTES FROM APRIL 2023**

## DOH/DDSD DIRECTOR'S REPORT: ALTSD SEC. KATRINA HOTRUM-LOPEZ:

- Work continues on the rate studies; meetings are ongoing.
- Regarding the provider rate increase approved in 2023 legislative session, leadership is working with CMS. ADCAP had questions about whether this will be retro if it doesn't go out until July 1.
- The transition of DDSD to the new Healthcare Authority is in the planning stages. More information will be coming in the next several months.
- Follow-up from the statewide investigations is ongoing. Only a handful of ANE cases were found, most providers are doing a good job. Visits will continue but in a more strategic manner.
- Discussion on balancing the critical role telehealth can play versus the effectiveness of telehealth for therapy as well as the need for hands on visits to ensure the safety of individuals.
   Tracy Perry stated the therapy provider network would love to meet with Secretary Hotrum-Lopez for further discussion.
- Discussion on the critical need for trained caregivers who people trust.

• The ACQ thanked Sec. Hotrum-Lopez for providing the report for the meeting and offered to be available in any way to work with her.

## STATUS OF ACQ STATEMENTS ON THE HEALTHCARE AUTHORITY AND TELEHEALTH- DANIEL EKMAN

- Daniel Ekman reviewed the letter written based on the discussion from participants.
- The letter will be sent to DOH and DDSD leadership pending review by ACQ members.
- People are encouraged to send their own letters in addition to the statement from the ACQ.

#### **SUMMARY OF 2023 LEGISLATIVE SESSION: REP. KATHLEEN CATES**

- Representative Kathleen Holmes Cates and Rep. Liz Thompson hosted a listening session in Albuquerque with Cabinet Sec. Patrick Allen and ALTSD Sec. Katrina Hotrum-Lopez. The intent of the session was to listen to stakeholders' concerns about the recent state-wide visits of all DD Waiver providers. Numerous concerns were expressed. Rep. Cates and Rep. Thompson drafted a letter summarizing the concerns expressed and submitted the letter to Cabinet Sec. Allen and the Gov. Chief of Staff. The ACQ requested a copy of the document which will be provided. Additional listening sessions are scheduled.
- HB 395, Dev. Disability Support Provider Employees, passed during the recent session. This bill
  requires DOH to collect and report demographic and compensation data on DD direct support
  provider agency employees. The results of the data will help inform the pay rate for direct
  support professionals.
- Home modifications: Waiver plan had \$10,000 every 5 years that was cut down to \$5,000 dollars. The bill, which failed, was to waive the Gross receipts Tax paid on home modifications.
   Legislation will continue to be introduced on this issue and additional money will be requested.
- The ACQ expressed many thanks to Rep. Cates and Rep. Thompson for their advocacy on legislation of importance to the disability community. Rep Cates agreed to continue her engagement with the ACQ.

## THE ACQ BY-LAWS- DANIEL EKMAN

- Daniel Ekman reviewed all recommended changes to the ACQ By-Laws in detail.
- After discussion, the draft By-Laws were voted on by ACQ members with the suggested revisions.
- Lisa Blue moved to approve the draft By-Laws with the revisions, Laura Matthews seconded the motion and the motion passed unanimously.

## STANDING COMMITTEE UPDATES- LISA BLUE

Mi Via Advisory Committee Update- Stevie Bass (MVAC Rep) and Elaine Hill (DDSD Rep).

Eliane: Monthly contact forms for Mi Via consultants will be completed on Therap starting on
July 1. Will participate in BETA testing. Will allow DDSD to see every contact consultant has with
individuals being served. DDSD will provide two separate training courses to consultant agencies
and set up the training courses. SSPs will be used by consultants starting 7/1 (Updated). Mi Via
training is mandatory. All roles have to complete ANE training before working with any

- participant on an annual basis. Compliance date with all other trainings extended to July 1 (EXCEPT ANE). Will provide training link in notes.
- Stevie Bass will be leaving the ACQ in October after serving 9 years as the MVAC rep! Many thanks to Stevie! The MVAC will be selecting a new representative for the ACQ.
- The MVAC is creating a tutorial subcommittee for the MVAC which will focus on training.
- Discussion on MVAC membership categories to include representation from the vendors. Some MVAC vendors are feeling left out of the process/unable to provide a voice by being unable to be an MVAC member. Clarification was provided that MVAC serves in an advisory capacity and has set up a separate MVC vendor meeting to address their concerns.

## Status of the ACQ Rate Study/Provider Capacity Comm.-Evangeline Yanez

- The Rate Study Comm. is in Phase 6, which is analysis and developing findings and
  recommendations. There was a meeting on June 6 to discuss the initial findings. PCG distributed
  three capacity assessment surveys. One for participant guardians, one for case managers and
  one for DD/Mi Via service providers. PCG will present its provider capacity assessment report by
  September 30, 2023.
- According to DDSD the 5% ARPA money is on track to occur. Secretary or Acting Director or HSD would be sources.

## DISCUSSION TO RECORD THE ENTIRE ACQ MEETING NOT JUST PUBLIC COMMENT-TRACY PERRY

- Transparency is important. Recordings can be utilized when discussing issues. People can view meetings when they want.
- DDSD shared what they have learned from the MVAC request to record the entire meeting and
  post it on the DOH/DDSD website. Issues include getting written consent every meeting from
  every participant, content must be reviewed for HIPAA breaches, possibly size issues, etc.
- Since the ACQ Public comments are posted on UNM/CDD's website, it is possible there are different regulations. This question will be pursued.
