# Mi Via Self-Directed Waiver NEW Standards and Services

Beginning March 2016, the Department of Health/Developmental Disabilities Supports Division (DOH/DDSD) will begin conducting presentations on the new Mi Via Service Standards. Reminder: Participants who have been approved for a computer, as part of their Mi Via budget, to manage their program online, should access FOCoSonline to enter and approve timesheets, enter payment request forms, and manage their budget. Managing your budget online is easy. Entering and approving timesheets online ensures timely payment for your employees. FOCoS online training is free. Call Xerox to enroll.

### **Transportation**

Reminder: Mi Via Service Standards state that "Transportation services are offered in order to enable participants to gain access to waiver and other community services, activities and resources... The service will be provided as specified in the participant's service and support plan and budget". Transportation for the purpose of vacation is a non-covered service in the Mi Via Rule (NMAC 3.14.6). Participants must use the transportation service as it is written and specified in the SSP and budget. Inappropriate use of transportation services will result in denial of payment for this service.
