## COMMUNITY LIFE ENGAGEMENT PROJECT

What is Community Life Engagement (CLE)? According to the Center for Community Inclusion (ICI) at the University of Massachusetts - Boston, "Community Life Engagement refers to supporting people with IDD to access and participate in their communities outside of employment as part of a meaningful day. Also referred to as community-based non-work, wraparound supports, holistic supports, or community integration services, Community Life Engagement activities may include volunteer work; postsecondary, adult, or continuing education; accessing community facilities such as a local library, gym, or recreation center; participation in retirement or senior activities; and anything else people with and without disabilities do in their off-work time. Such activities may support career exploration for those not yet working or between jobs, supplement employment hours for those who are working part-time, or serve as a retirement option for older adults with IDD."

Think Work recently announced that they would be funding a pilot project related to CLE. Eleven states submitted applications to participate in this project. Two were selected, including New Mexico! Applicants were selected based on the level of interest in expanding and/or improving CLE supports in the state and their level of investment in the systems change process.

DDSD will be partnering with Dava Matillano, from the ARCA ACES program, Juanita Watson, from Benchmark Human Services, Doris Roberts, from All Individuals First and Glen Carlberg from Collins Lake Ranch. After an initial kick-off meeting, the Think Work project team will conduct site visits in New Mexico and the selected providers will start to use a newly created CLE Toolkit. The CLE Toolkit will be used for eight months. During that time, monthly technical assistance calls between New Mexico and the CLE project team will report on progress and satisfaction data. This is an incredible opportunity for national experts to assist providers in New Mexico with redesigning services to improve CLE outcomes, as well as attaining compliance with the CMS Final Rule. The results of this project will be shared nationally and will help shape the future of services. We look forward to sharing our results at the conclusion of this project!

## Renewal of the Traditional Developmental Disabilities Waiver

### Opportunities for Formal Public Input on the State's Renewal of the traditional Developmental Disabilities Waiver

The DD waiver is a home and community based services (HCBS) waiver that must be approved by the federal Centers for Medicare and Medicaid Services in order for the state to receive federal funding. The **federal regulation governing HCBS waivers** allows for a five year renewal period. New Mexico is seeking formal public comment before submitting a DDW Renewal Application to CMS. Below are important dates to keep in mind.

September 15, 2016	Tribal notification and comment period begins.	
October 15, 2016	Public notice and comment period begins.	
November 15, 2016	Public hearing and public comment period ends.	
December 2016	Waiver Renewal to be finalized based on public comment	
	received and submitted CMS for approval.

# **Certified Employment Support Professional (CESP)**

APSE, the Association of People Supporting Employment First created the first national certification program for employment support professionals called the Certified Employment Support Professional™ or CESP™ certification. The CESP™ program is the first in the nation to create national guidelines to validate and support the training currently provided in the field.

Unlike training programs that provide a certificate of completion, the CESP™ certification sets a standard of knowledge and distinguishes employment support professionals who have shown they have the skill and competence to perform the requirements of the job. The CESP™ exam seeks to define the benchmarks for knowledge and competency in the field in the following areas: 1) Application of Core Values and Principles to Practice & Legislation and Funding; 2) Individualized Assessment and Employment/Career Planning; 3) Community Research and Job Development; 4) Workplace and Related Supports and 5) Ongoing Supports.

In June of 2016, Partners for Employment, a collaboration between the UMN/CDD, DDSD and the Division of Vocational Rehabilitation (DVR) brought the examination to New Mexico and offered scholarships for the cost of the test.

## Fair Hearings Update

To assist individuals and families through the hearing process, DDSD created a unit to centralize matters related to waiver related Fair Hearings. DDSD generates hearings from a variety of sources; Intake and Eligibility, Mi Via, H Authorization and the Outside Reviewer (OR). The DDSD Fair Hearings Unit receives all hearing acknowledgements from Human Services Department, Fair Hearings Bureau, compiles the Summary of Evidence (SOE) for the Parties and the Administrative Law Judge and works with all interested Parties to schedule and conduct an Agency Review Conference in the hopes of resolving issues outside of the hearing. Since the implementation of the OR in the Fall of 2015, DDSD has received 156 requests for a Fair Hearing.

Frequently, Fair Hearing cases are resolved through action items discussed and acted upon via the Agency Review Conference process. The DDSD Fair Hearings Unit strives to provide excellent customer service and assistance to individuals, families, guardians, case managers and providers in order to efficiently resolve issues outside of the formal hearing. The Agency Review Conference is a valuable resource and DDSD encourages people to take advantage of this process if a Fair Hearing is requested.

# The Importance of Working with the Provider Enrollment Unit

The PEU's main purpose is to ensure that all Developmental Disabilities (DD) Waiver providers, Medically Fragile (MF) Waiver providers, and Mi Via Consultants have an active Provider Agreement and to ensure that the Secondary Freedom of Choice (SFOC) forms are accurate. Anyone who needs information on providers, providers who need assistance in enrolling in one of our three waivers, current providers who need to renew their Provider Agreement or current providers who need to make changes to their Provider Agreements do this all through the Provider Enrollment Unit (PEU). Did you know that the PEU also:

- Ensures current providers have an active Medicaid number;
- Processes Provider Agreements and verifies that provider information (i.e. legal name, address, phone numbers, email address), service(s) and county(ies)/region(s) is accurate;
- Processes amendments or changes to Provider Agreements as needed;
- Processes both self and State imposed moratoriums;
- Maintains licensure for contactors, nurses, nutritional counselors, social workers and therapists:
- Obtains Medicaid numbers for new providers;
- Keeps all providers and interested parties abreast of correspondence coming from DDSD;
- Tracks accreditation;
- Has created and assisted with creating DDSD policies;
- Maintains the PEU database and generates reports as requested;
- Assists other units with projects;
- Handles those occasional phone calls when an individual and/or guardian have questions about the waiver
  or how they go about placing an individual on the waiting list and so on; and
- Works alongside all Regional Offices, the Division of Health Improvement (DHI), Medicaid, Xerox, NM
  Taxation and Revenue Department, accrediting agencies, licensing boards, the IT Supports Division and
  any other entity that can assist us with getting our jobs completed.

## FIT Annual Meeting Focuses on Quality Practices

The Family Infant Toddler (FIT) Program held its annual meeting at the Indian Pueblo Cultural Center on June 22 – 23, 2016. With over 160 participants from the 34 FIT provider agencies from across the state!! The theme for the meeting was "New Mexico You!" and we did a gift exchange with items (food /

souvenirs) that providers brought that represented their community!

After a welcome address from Cathy Stevenson (DDSD Director), the first day included a focus on the work being conducted under the Race To the Top – Early Learning Challenge Grant to develop a Tiered Quality Rating and Improvement System (TQRIS). One provider panel highlighted the work to promote evidence based early intervention practices through the use of video recording of home visits that are then reviewed in a reflective coaching session. Larry Edelman from Colorado, who is working with the FIT Program to promote the use of video technology, presented a video montage of testimony from practitioners who are participating in the pilot. The pilot includes utilizing the SSOOPPRR tool as part of Family Guided Routines Based Intervention approach <a href="http://fgrbi.fsu.edu/index.html">http://fgrbi.fsu.edu/index.html</a> as part of our collaboration with Juliann Woods Ph.D. from Florida State University. The second provider panel focused on the pilot of the IFSP (Individualized Family



Service Plan) Quality Rating Scale as a tool to promote functional, routines-based and family centered IFSPs. Providers reported significant changes in practices in both pilots.



The meeting also included a number of breakout sessions including: FAN (Facilitating Attuned iNteractions); Trauma Informed Care; A Families Journey Through Early Intervention; Developing Family Leaders; and Integrating Early Childhood Outcomes into the IFSP. Other sessions included ABA Approaches within Autism services and an "Open Space" session where providers were able to host dialogue sessions with other providers around chosen topics.

A big thanks to all the presenters and to the FIT and UNM Early Childhood Network staff that organized this successful meeting – where we all learned from each other in our effort to promote evidence based early intervention practices!!
