# COMPREHENSIVE RATE STUDY WRAPPING UP

On May 14-16, 2019, DDSD's contractor, Public Consulting Group (PCG), hosted a series of face-to-face meetings with DDSD, the ACQ Rate Study Subcommittee and the public. The purpose of the meetings was to review initial findings collected from the Cost Tool, Personnel Roster and Time Study Tools completed by DD Waiver and Medically Fragile Waiver providers, along with Mi Via Waiver Consultants and In-Home Living Supports providers.

PCG will return to New Mexico to review Rate Recommendations with DDSD, the ACQ Rate Study Subcommittee and the public, June 18-20, 2019. The public meeting will be June 19, from 1:30-4:00 at the State Capitol Round House, 211 Old Santa Fe Trail, Santa Fe, NM 87501 in Room 307.

The Rate Study will be completed by June 30, 2019.

## REVISED DD WAIVER & MEDICALLY FRAGILE WAIVER PROVIDER APPLICATION

Over the past year, the Developmental Disabilities Supports Division (DDSD) has been working on revisions to the current Developmental Disabilities (DD) and Medically Fragile (MF) Waiver Provider application.

The Provider Application was last revised in 2014. Many things have changed over the years, so it was time for some revisions. The Centers for Medicare and Medicaid Services (CMS) requires each state to demonstrate that it has designed and implemented a system for assuring that all waiver services are provided by qualified providers. This starts with our Provider Application.

Reasons to revise the Provider Application:

- Include best practices for service provision
- Align with the current DD Waiver Service Standards
- Incorporate federal requirements (i.e. CMS Final Rule)
- Comply with the Jackson Settlement Agreement
- Increase the quality of providers

Some exciting features in the revised Provider Application include elements that will address professionalizing the work force, person-centered practice, accountability, financial responsibility and ultimately result in better outcomes for people within our system. Scoring criteria is also being developed to ensure transparency and consistency across reviews, and to set our providers up for success.

DDSD will be training providers on the Application in July 2019 and implementation will take place on August 1, 2019. Please be on the lookout for more information related to revising the Provider Application and the upcoming trainings.

## RESOURCE COLUMN

There are some wonderful resources for individuals with disabilities & their families in New Mexico. In this newsletter, we are highlighting access to information and resources regarding Guardianship, and Alternatives to Guardianship - such as Power of Attorney, or Health Care Decision-Maker, and Representative Payee.

## **Guardianship/ Guardianship Successor Planning**

As the individuals we serve get older, as well as their parents/guardians- it is important that there be a plan in place regarding Guardianship/ Alternatives to Guardianship and/ or Guardian Successor. The issue of Guardianship Successor continues to become more critical as there have been several instances in the last couple years of individuals whose elderly parent/guardian pass away, and the individual (deemed not able to make decisions by the court), is left without a decision-maker, as there is no plan in place regarding a guardian successor.

**Guardianship** removes considerable rights and should only be considered after alternatives have proven ineffective or unavailable. The legal processes are complicated and can lead to overstepping and family fights, and families and individuals are strongly encouraged to get expert help.

Under New Mexico Law, if a person is incapacitated and has not given power in writing to an agent, a court can appoint a guardian over the person and a conservator over financial matters. This can be a family member or corporate guardian. A guardian can then make residential placement and health care decisions and a conservator can make financial decisions. A court can also appoint a temporary guardian or conservator if needed to prevent immediate and irrevocable serious harm. A court can also limit the powers of the guardian and conservator depending on the person's capacity and needs.

**Alternatives to Guardianship** include Power of Attorney, while the individual is still capable and understands what they are signing, Representative Payee- managing Social Security/SSI payments, Surrogate Decision-maker for healthcare, and informal arrangements with family members.

## MI VIA WAIVER RENEWAL

The Department of Health (DOH) and the Human Services Department (HSD) collaboratively engage stakeholders through the waiver renewal process to collect input regarding program and policy recommendations. To date the departments have hosted meetings with the Mi Via Advisory Committee (MVAC) Renewal Steering Committee, Mi Via Consultant Agencies and with vendors in the system. Renewal meetings with stakeholders will continue to take place over the summer months. During the months of May through July 2019, DDSD and HSD will be hosting statewide Town Hall meetings to engage with the public. The purpose of these meetings is to provide information and to receive comment on the proposed Home and Community Based Services (HCBS) Medicaid Mi Via Waiver.



## Preschool Development Grant Birth—5 (PDG B-5) Kick-off Meeting

On May 01, 2019 we held a kickoff for New Mexico's Preschool Development Grant Birth - 5 (PDG B-5) work. We were excited to meet with close to 100 stakeholders (parents, early learning providers, advocates, funders, policy makers and others) in Albuquerque, who provided input into statewide early learning 'Needs Assessment' and 'Strategic plan' process that will be conducted this year. FIT Program helped facilitate and take notes during the small group work.



#### The meeting goals were:

- •To share the overview, vision and process of the PDG B-5;
- •To collect input that will help inform NM's early learning Needs Assessment and Strategic Plan activities of the PDG B-5;
- Explore ongoing ways that stakeholders can be involved in the success of New Mexico's early learning Needs Assessment and Strategic Plan.

## ABLE NEW MEXICO

New Mexicans living with disabilities can now save money and keep their public needs-based benefits! By opening an *ABLE New Mexico* online account, eligible individuals can save up to \$15,000 in a calendar year (\$468,000 lifetime limit) and invest, OR, spend their money on items that maintain or improve their health, independence, and quality of life. The ABLE (**A**chieving a **B**etter **L**ife **E**xperience) Act was passed federally in 2014, and here in New Mexico in 2016, and was largely the work of a man named Stephen Beck, Jr.

He had a daughter living with a disability and he was frustrated at the lack of options available to plan for her future without risking the loss of her benefits. Mr. Beck worked with other parents who had similar concerns, and, with leaders within the disability community to have Section 529 of the Internal Revenue Service's Code of 1986 amended to allow for the creation of ABLE accounts which are similar to 529 college savings accounts.

The accounts are owned by individuals living with disabilities who were diagnosed before the age of 26, and can be opened and administered by the individual or their authorized legal representative (parent, guardian, or power of attorney).
