By Prescription

The primary purpose of a family planning clinician is to provide contraceptive services to essentially healthy people, <u>NOT</u> to be the primary care agent.

If a client needs treatment by a non-contraceptive medication not stocked by the PHD Pharmacy, they may purchase it at their own expense through a prescription written by a duly licensed clinician.

Prescriptions for contraceptive methods should only be sent to a pharmacy if this is preferable to the client.

The pharmacy provides single copies of current drug monographs for nurses to copy that contain client information about the drug being dispensed. They are to be given with all prescription drugs dispensed as mandated by the New Mexico Board of Pharmacy.

Title X service sites that are unable to provide clients with access to a broad range of acceptable and effective medically approved family planning methods and services, must be able to provide a prescription to the client for their method of choice or referrals to another provider, as requested. (42 CFR § 59.5(a)(1))

Hormone contents in the oral contraceptive pills (OCPs) may include:

- 1. **Progestin:** two derivatives
 - a. Estrane ("Thin/Thyn" in the name) Norethindrone is the active form.
 - b. **Gonane ("Gest" in the name) –** Levonorgestrel, Norgestimate (which active form is also levonorgestrel but has less androgenic activity)
- 2. **Estrogen:** ETHINYL ESTRADIOL (EE) In this table, OCPs are listed in incremental EE dosage from zero to 35 mcg. Higher EE dose helps with breakthrough bleeding and spotting in early cycle.

OCPs with <u>underlined names</u> are Title X preferred brands.
