Mi Via Required Trainings

All staff (Consultants/Employer of Records/Direct Support Professionals) are required to take the following trainings to work with any Mi Via participant.

All Participants will be given the New Mexico Department of Health Reporting Suspected Abuse, Neglect and Exploitation Flyer (ANE) and will review with their consultant. The participant will sign the ANE acknowledgement form.

Abuse, Neglect and Exploitation (ANE)

All Employer of Record (EORs), employees, vendors, and volunteers will be required to complete the ANE Awareness training. EORs, Consultant Agencies and vendor agencies are responsible for ensuring the training requirements outlined below are met.

- 1. DDSD ANE Awareness On-line trainings shall be renewed annually with successful completion of the DDSD ANE Awareness
- 2. Training shall be conducted in a language that is understood by the participant, EOR, Consultant, vendor, employee, or volunteer.
- 3. Training must be conducted by a DOH certified trainer or through online asynchronous course.
- 4. Documentation of a participant, EOR, Consultant, employee, vendor, or volunteer's training must be maintained for a period of at least three years, or six months after termination of an employee's employment or the volunteer's work.
